n the Friday before Easter, Christians commemorate Jesus Christ's crucifixion. This day of remembrance, known as "Good

The

Friday," originated during the early Christian era. In many parts of the world, the day is marked by solemn religious ceremonies and folk customs. Church rituals memorialize the biblical account of Jesus' crucifixion, in which soldiers close to Jewish religious leaders arrested Jesus on the evening of the Passover dinner. The next morning, the Roman ruler interrogated, beat, and sentenced Jesus to death. Roman soldiers placed a crown of thorns on his head. Broken and bleeding, Jesus was carried to Crucifixion, where he was nailed to a cross. That afternoon, he died on the cross. The most closely associated symbol is the cross or crucifix. Another sign of the occasion which recalls the crown of thorns placed on Jesus' head by Roman soldiers in an attempt to afflict and ridicule him.

Good Friday can also be referred to as Black Friday, Great Friday, or Holy Friday. Many countries around the world observe Good Friday as a national holiday, particularly Anglican and Catholic ones. This holy day is

marked by fasting and solemn observances. Good Friday was first observed in the fourth century by Egeria. The term "Good Friday" is derived from the phrase "God's Friday". celebrations took place in the second century in key ancient towns such as Rome, Jerusalem, and Alexandria. These events took place on the Sunday following



Passover. A two-day fast preceded the Easter feast in some communities who practiced this ritual. Others, however, believe that the first Easter celebrations took place in second-century Asia Minor, which is today known as Turkey. Christians in this region placed a special emphasis on Jesus Christ's sacrificial death, a motif that was eventually allocated to Good Friday. They, like their Roman counterparts, named the holiday Pascha," a Greek word derived from the Hebrew word Pesach, which means Passover. Similarly, the Asia Region Christians celebrated Pascha on the same dates as their Jewish neighbours, on the fourteenth and fifteenth days of the Jewish month of Nisan. Fasting, prayers, and recitation from literature, along with the teachings of Jewish prophets and the Passover account as told in the Bible's Book of Exodus, were all part of the celebrations.

courtyards and chapels built over the crucifixion, burial, and resurrection of Jesus. They spent the morning praying at the Stations of the Cross. The people began attending a

> series of Bible readings in the afternoon, which included the writings of the texts verifying Jesus' fulfillment of these Old Testament predictions, as well as the Passion account. Another scripture session was held after that, which ended around seven o'clock in the evening. The church then initiated yet another ritual honoring Jesus' burial. Following the conclusion of this event, the clergy and worshipers began a protracted vigil around Jesus' tomb. Throughout the middle ages, Good Friday celebrations evolved. Human sin, the need for redemption, and Christ's suffering and sacrificial death were all highlighted in mediaeval Good Friday festivities. As a result, they took on a serious mood. Passion plays, folk dramas recreating the events of Jesus' last days, were also used by Christians to emphasize the terrible events of Good Friday.

> Fasting, a religious practice primarily linked with Good Friday, although many Lenten fasting rituals have been abandoned by

Roman Catholics in the last century or so, Church authorities nevertheless require the believers to fast on Good Friday. Astute Christians fast throughout Lent. Anyone that does not fast for the entire Lenten season will frequently fast throughout Holy Week, particularly on Good Friday. On Good Friday, some devout Christians intensify their fast, going without eating from Good Friday through Easter Sunday. Many other Christians practise some type of fast on Good Friday, despite the fact that their faiths do not demand it. Historically, many Irish Christians observed a "black fast" on this day, a regimen consisting of nothing but tea and Water.

There were numerous contradictory testimonies against Jesus, as well as numerous witnesses, and Jesus remained oblivious to all of this. The high priests then compelled Jesus to take the sacred oath, asking, "I adjure you, by the Living God, to tell us, are you the anointed One, the Son of God?" "You have stated it, and in time you will see the Son of Man seated at the right hand of the Almighty, coming on the clouds of Heaven," Jesus remarked cryptically. The Sanhedrin passed the death sentence on Jesus that day, after the high priest accused him for sacrilege. The interrogations proceeded just as Jesus had prophesied.

r. Bhim Rao Ambedkar, a fighter for caste eradication, was born on April 14, 1891 in a low-caste Mahar family at Mhow cantonment, which is presently Ambedkar Nagar in M.P. His Father Ramji Makoji Sakpal's was an army officer in the British India army. His family was of Marathi origin, hailing from the town of Ambawade. Dr. B R Ambedkar was born into a caste that was thought to be the lowest of the low. He was regularly subjected to social and economic prejudice, and was denied the right to sit with other kids.

Even after enrolling in a local Satara school, Ambedkar's experience with caste discrimination did not cease. Discrimination appeared to be pursuing him. When he returned from America, the King of Baroda chose him as his defense secretary. Even though he held such a high position, his upper-class authorities referred to him as "untouchable."

Dr. Ambedkar fought against Brahmanical Patriarchy, bold plans for the Hindu Code Bill, and proposals for a major restructuring of property relations all point to his challenge to the existing status quo. Dr. Ambedkar, possibly India's greatest radical thinker,




altered the social and political scene in the fight against British colonialism by making the oppressed politically aware of their own plight. "Educate, Agitate, and Organize," Ambedkar famously told everyone.

Ambedkar was the only one of his siblings who passed his exams and got to high school. His life was marked by adversity, as his extreme recommendations to address the Caste System were received with open hostility from the Upper Castes. Not only did he overcame all institutional and structural hurdles to continue his studies, but he also received a Doctorate in Economics from Columbia University in 1917. The man who faced humiliation as a result of his caste became the first Minister of Law in free India and helped create the country's Constitution.

Evidently, he placed a high value on education, particularly in areas where it had previously been denied. In fact, he is believed to have stated that education was more essential than Temple entry for the oppressed. He regarded education as a powerful tool that could strengthen every person to assist construct an egalitarian society and help remove the age-old restricting constraints of unequal social practices. We should aspire to embrace his ideals and assist future generations in building a comprehensive, democratic, and liberal society in Modern India.

otherhood is a crucial stage in a woman's life, and she requires the utmost love and protection during this time. The goal of National Safe Motherhood Day is to make motherhood the most wonderful experience in the lives of all mothers.

Every year on April 11, National Safe Motherhood Day is honoured. It is a White Ribbon Alliance India program (WRAI). The day is marked to raise awareness about women's prenatal and postoperative care and necessities. India is the world's first country to have a socially acknowledged National Safe Motherhood Day. amid coronavirus, safeguard mother and infant." The initiatives seek to raise awareness of the fact that every woman has the right to live and survive pregnancy and childbirth. On National Safe Motherhood Day, members and non-governmental organizations (NGOs) gather to share information and technical experience. The White Ribbon Alliance observes National Safe Motherhood Day to raise awareness about appropriate access to care during pregnancy, childbirth, and the postnatal period, with a focus on minimizing anemia. India is responsible for 15% of all maternal fatalities worldwide. Despite the fact that more than 80% of women give birth in a health facility, the fatality rate is significant. "Every year, 44,000 women die in India as a result of poor prenatal care," according to the World Health Organization.

It is a coalition of 1800 organizations. In 1999, the WRAI was established. The government chose this day since it is the birth anniversary of Kasturba Gandhi, the wife of Mahatma Gandhi.

Every year, WRAI members choose a topic and organize activities to raise awareness about maternity care and good healthcare for pregnant and nursing women. The purpose of these WRAIorganized activities is to raise awareness of the fact that every woman has the right to live and survive pregnancy and delivery. The topic for year 2022 is "Remain at home

child marriages, which may be an indirect cause of maternal fatalities. Because of the COVID-19 outbreak, it has been declared a Public Health Emergency is an International Concern. All pregnant mothers, whether or not they have been diagnosed with COVID-19, should have access to advanced care. This includes prenatal, newborn, postnatal, postpartum, and mental therapy. COVID-19 is a severe threat to the most vulnerable people in our life, but there are simple precautions we may take to keep them safe. Right now, staying at home is the greatest option. Pregnant women should avoid going out unless they have an emergency medical need conveyed by the World Health Organization.

The government has launched a range of national initiatives to help pregnant women. The Indian government has launched Janani Shishu Suraksha Karyakaram to urge people who still want to deliver at home to choose skilled birth attendants. It is a campaign to verify that JSSK benefits reach every needy pregnant lady who visits a government institution.

Janani Shishu Suraksha Karyakaram (JSSK), which was introduced on June 1, 2011, makes all pregnant women who delivered in public healthcare facilities entitled for essentially free and no-cost delivery, including caesarean. Complimentary facilities for ; medication and supplies, diagnostics, blood wherever needed, and diet for 3 days during normal delivery and 7 days for C-section are among the benefits. It also offers free transportation from home to the institution. In 2014, these benefits were expanded to include prenatal and postnatal problems of pregnancy. Similar entitlements have been established for all sick newborns and infants seeking treatment at public health institutes.

The majority of maternal deaths are avoidable. If women seek health-care options to prevent or manage difficulties, they are more likely to succeed. All women should be informed of the importance of prenatal care, as well as care during and after childbirth. Maternal and infant health is deeply entwined. As a result, it is critical that all births are attended by trained health professionals in order to give timely treatment. This will make the difference between life and death for both the mother and the baby and both live a healthy life.

On April 11, 2003, the Indian government recognized April 11 as National Safe Motherhood Day. It was carried out at the request of the WRAI. When the Centre for Catalyzing Change, an NGO, brought together a number of individuals and organizations to campaign for safe motherhood in India, the White Ribbon Alliance for Safe Motherhood India was created. The objective of the WRAI is to inspire, support, and assist proponents of campaigns that women's rights to be protected during child - bearing age and even during the childbirth process.

TIGER OF MYSORE, TIPU SULTAN, THE DOYEN OF HEROISM!

ipu Sahib or the Tiger of Mysore a man with umpteen pieces of identification popularly known as Tipu Sultan, who is sure to be esteemed as the bravest spirit who fought a war against the British. with assiduous travailing, ineluctable vicissitudes, he irrefutably emerged as the doyen in the field of war. People are losing sight of the original fact that Tipu Sultan was the emperor remembered for his remarkable tales of bravery and courage.

The first-born son of Sultan Hyder Ali of Mysore, under the able tutelage of his father at the delicate age of 17, he earned afflatus and assisted his father in the battle of 1776. Upholder of revolution and to get the ball rolling, he commenced the coinage and built up a new land revenue system that expedited the thriving business of the Mysore silk industry, but that is not all, he also introduced the Mauludi lunisolar calendar.

When India was beleaguered by the British and they had kept accelerating the power in every possible field, Tipu worked assiduously with zest and got his gun makers, clockmakers, engineers, and, other experts from France. He then put up his manufacturer of bronze cannons, muskets, and ammunition.

To exert the power of his glory more vigorously, Tipu had the tiger images on his every paraphernalia including textiles, coins, his soldier uniforms, and swords. And that is when Tiger fame was all the rage for the Tipu sultan. There is another folktale that has been told again and again, often for generations, according to which on one occasion, when he went into the forest for hunting. Tipu Sultan came up against a great deal of resistance in dealing with the Tiger before him. As he approached to shoot the animal, the Tiger struck wildly at him at the same time. Afterward, Tipu Sultan also lost the grip of his dagger and it fell to the ground. But the sharp-witted Tipu was quick off the mark with Tiger, on which, without further ado, he hurried down, picked up his dagger, and killed the tiger thereupon. Consequently, he manifested himself as the Tiger of Mysore.

it became obvious that all his efforts were in vain. Having been apprised of the situation and seeing this as an opportunity, the Britishers spearheaded the deliverance for Travancore. However, later when Coimbatore was under British sovereignty, Tipu Sultan had put a stop to British East India company from advancing further. Thus, becoming a threat to Britishers.

It was in 1791 when Britishers had held the

power in

Bangalore and set out to seize the Srirangapatnam, then to block the access of supplies to Britishers, Tipu destroyed the local resources. In whatever way, a year later Britishers were successful and won a victory over Tipu's territory. After the secession of the state from the Tipu Sultan, Britishers exacted promises to cede half of his territory and two of his sons as captives.

In 1799, it was the cessation of the Sultan's sultanate in the fourth Anglo war, when Hyderabad Nawab came to the aide of Britishers and attacked Srirangapatnam. Following this, he was put to death and buried next to his father. As he never gave up easily in his whole life, Tipu's quality of combatant was unsurpassed. He was the one who invigorated the tough war against Britishers. That is why, Britishers extolled the virtues of Tipu, as he was the one who fought relentlessly till his last breath against their advancement.

Rani Rampal, a talent with a combination of ability and consistency, has given the Indian women's hockey squad a much-

Rani took on the captaincy with confidence, leading the side to triumph in the Asia Cup after 13 years and then through the World Cup qualifying in 2018. Rani is certain that the team's current condition and performance made India reach to Tokyo Olympics for the first time in the history of India in 2020. he ranks of billionaires waned in the last year. The pandemic has caused their total worth to drop by \$400 billion. According to Forbes' annual World's Billionaires list there are 2,668 billionaires around the world. Last year 87 billionaires couldn't keep up in this intense situation. These 2,668 billionaires combined worth is \$12.7 trillion. The covid pandemic for 2 years has caused immense market disruptions. The Russian Ukraine war caused crude oil prices to cross \$100 per barrel which hindered the growth of many industries. The stock markets were in a shaky position. The U.S. has the maximum billionaires count, that is, 735, followed by China's 607. Elon Musk, the founder of Tesla and SpaceX topped Forbes' list for the first time with a net worth of \$219 billion. On seeing the Forbes list, we can say that more than half of the top 10 billionaires earned their fortunes in the technology sector.

The top 10 billionaires are-

1. Elon Musk (\$219 billion): He is the founder, CEO at SpaceX. He was encouraged by plans to place a growth-chamber for plants on Mars. Musk had a net worth of \$27 billion at the beginning of year 2020. By the end of 2020, his net worth had increased by \$150 billion which was largely due to his ownership of around 20% of Tesla stock.

4. Bill Gates (\$129 billion): The major entrepreneurs of microcomputer revolution. He is the cofounder of Microsoft along with his late friend, Paul Allen.

5. Warren Buffet (\$118 billion): He started investing from 11years. He is the CEO of Berkshire Hathaway. He is called the Oracle of Omaha. He believes in frugality.

6. Larry Page (\$111 billion): He is the owner of Google. He is the man who created Google along with Sergey Brin. Google is being used by millions of people in today's world. Larry Page is an American computer scientist and an entrepreneur.

DEMOGRAPHIC DIVIDEND MAY SANS **ENOUGH JOBS AND SKILLED WORKFORCE**

ndia's demographic dividend may turn into a liability in the absence of Lrequired jobs and skilled labour force. A demographic dividend means the growth of an economy as a result of the age structure of a country's population. Declining fertility and mortality rates typically bring a change in age structure. A country that experiences low birth rates with low death rates an economic dividend or benefits from the increase in productivity of the working population. As the labour participation force increases, it is considered that the country will reap the benefits of its resources.

The government has to take care of job opportunities to reap benefits of demographic dividend. As the country is expected to add another 183 million people to the working age group of 15-64 years between 2020-2050, the ٠ problem of reaping benefits is becoming difficult. Confederation of Indian Industry reported that working age population is necessary but not sufficient for it to sustain the economic growth. It's high time for India to create new jobs and adept the workforce for those jobs otherwise the demographic dividend may turn into liability. 

MAHARASHTRA GOVERNMENT HAS BEGUN TO **USE BLOCKCHAIN TECHNOLOGY FOR CASTE CERTIFICATE VALIDATION**



he Maharashtra government began using a blockchainbased system for caste certificate validation on Thursday. Caste certificate validation currently requires a lot of manual intervention and is vulnerable to fraud and forgery, according to officials. False caste certificates can deprive qualified individuals of job or educational opportunities. The state government will now record all of the necessary information for a


caste certificate and issue it to the applicant. The data will be saved in the form of a QR code using blockchain technology once it is issued. According to Deependrasinh Kushwah, CEO of the Maharashtra State Innovation Society, any government department can then scan a candidate's QR code and cross-check his or her caste certificate. The first project has been chosen for the Etapalli sub-division of the Gadchiroli district. It has validated the castes of 65,000 people using blockchain technology. He also said that the government's citizen facilitation centres will soon begin issuing caste certificates with QR codes. LegitDoc, a start-up that won the Maharashtra government's 'hackathon' event in 2019, developed the technology. Additional collector Shubham Gupta stated that this will put an end to document forgery and misuse. It will save a significant amount of time and money. According to Neil Martis of LegitDoc, such verification and validation of key government documents is widely used in many counties. It's great that our country is following suit.

AFTER A BRIEF OUTAGE, ZOMATO AND SWIGGY **ARE BACK ONLINE**

sers in India were unable to access the food delivery apps Zomato and Swiggy. Users were unable to refresh the feed or place food orders. Several users reported receiving the message "Something went **ZOMATO** wrong. When they attempted to access the Zomato app, they received "Please try again later" messages. According to reports, the two apps SWIGGY crashed due to a technical snag caused by Amazon Web Services. Swiggy was only down for a few seconds, and Zomato appears to be functioning normally for users. However, it did cause problems for users while it was not operational. A user reported that his order was on its way when the app crashed, rendering him unable to track it. Another user complained that he couldn't order food for a few days after upgrading to Zomato's subscription plan. He, like many other users, was unable to access the food menu. Zomato and Swiggy responded to user complaints by saying they were investigating the "temporary glitch." Swiggy acknowledged the problem, saying that they were currently unable to process the request due to technical constraints. Not to worry, their brightest minds are working on it, and that they will be back up and running soon. Zomato, too, stated that it is working to resolve the "technical glitch." They are experiencing a brief hiccup. They have requested to be assured that their team is working on this and that they will be back up and running soon.



A NANOPARTICLE TRAPPED BETWEEN FUNCTIONS AS A QUANTUM SENSOR



ensors are a key component of the Internet of Things, providing data that can be used to control a wide range of objects. Precision is critical here, and this is where quantum technologies could help. Researchers are now showing how nanoparticles in tiny optical resonators can be transferred into the quantum regime and used as high-precision sensors. Advances in quantum physics open up new avenues for significantly improving sensor precision and, as a result, enabling new


technologies The researchers propose that by taking advantage of the system's fast unstable dynamics, the motional fluctuations of a nanoparticle trapped in a microscopic optical resonator could be reduced significantly below zero-point motion. Mechanical quantum squeezing reduces the uncertainty of motional fluctuations below zero-point motion, and it has previously been demonstrated experimentally with quantum resonators. The researchers now propose a novel approach, tailored specifically to levitated mechanical systems. Light is reflected between mirrors in an optical resonator and interacts with the levitated nanoparticle. Such interaction can result in dynamical instabilities, which are frequently regarded as undesirable. The study proposes a novel application of optical cavities as mechanical quantum squeezers, as well as a viable new route in levitated optomechanics beyond quantum ground state cooling. Thus, micro-resonators provide an intriguing new platform for the development of quantum sensors, which could be used in satellite missions, self-driving cars, and seismology, among other applications. The European Union provided financial support for the research in Innsbruck and Zurich.

It was Priyangka's first goal for the Blue Tigresses against Egypt, who were ranked 95th. The first half began with the Indian team pushing hard to take the lead. Captain Ashalata Devi attempted to take an early lead in the 18th minute with a longrange shot, but Anju, who latched on to the ball, missed the opportunity. Manisha almost scored the first goal of the night a few

minutes later when Dalima's pass from the right was intercepted by the Egyptian goalkeeper. Before the opposition could settle into the game, Priyangka scored in the 30th minute to give India an early lead that would stand as the only goal of the match. The second half followed a similar pattern, with India creating more chances as head coach Thomas Dennerby made his first substitution at the restart, replacing forward Renu with Pyari Xaxa. Engy Ahmed Sayed, the prolific captain, tried her luck from close range before the hour mark, but Sowmiya stood tall to confidently deny her. Hayam Abdellatif had Egypt's final shot in the dying minutes of the game, but it was saved by Sowmiya's gloves. The match was quickly over, with India claiming their first victory in Jordan. This is the first match since the national team was forced to withdraw from the AFC Asian Cup group stage, which India hosted in January-February, due to a COVID-19 outbreak inside its bio-bubble in Mumbai.

PV SINDHU'S CAMPAIGN ENDS IN THE SEMI-FINALS OF THE KOREA OPEN AFTER SHE FAILS **TO DECODE AN SE-YOUNG**

V Sindhu of India was defeated for the fourth time in a row by the young An Seyoung in the semifinals of the Korea Open Super 500 badminton tournament here on Saturday. The third seeded Indian tried everything but couldn't overcome the world number four Korean, falling 14-21 17-21 in 48 minutes. An Seyoung, 20, provided ample evidence of her athleticism with her diving returns to keep the rallies alive and didn't falter in her precision, leaving Sindhu to play catch-up from the start.
