# DIVINE LESSONS: THE TALE OF BRAHMA'S AWAKENING

Following her counsel, Lord Shiva traversed from one location to another, carrying the Kapala as a beggar. Wherever he received alms, it vanished upon touching the Kapala, leaving it empty. Finally arriving at Thirukkandiyur, the deity there dispatched Mahalakshmi to offer alms to Lord Shiva. Mahalakshmi, radiant in her divine form, poured alms into the Kapala, causing it to overflow and fall to the ground. Some versions of the legend suggest that Lord Vishnu, in an act of compassion, even sacrificed his own blood to fill the Kapala. Instantly liberated from the curse, Lord Shiva expressed gratitude to Lord Vishnu for his timely intervention. As Vishnu had relieved Shiva of his curse, he came to be known as HaraSaabaVimochanar, while Shiva remained in the place as Brahma Sira Khanedeeshwarar. The temple stands across the street from the Hara Saabha Vimochana Perumal Temple located in Thanjavur Dist, Tamil Nadu.

These stories serve to illustrate the law of karma, demonstrating that even the supreme Trinity cannot evade it, whether it be Brahma's improper attraction or Shiva's harm to the Creator himself. It serves also as a reminder that the moral order of the world must be upheld, and those who defy it will face significant consequences. The narrative serves as a poignant reminder that even creators are bound by the principles of righteousness and integrity.

From Brahma's saga, we glean the profound lesson that genuine creation entails more than mere manifestation; it involves upholding equilibrium and honoring the natural order and interpersonal boundaries. ### INDIA TO REVISE **AGRICULTURE EXPORT** POLICY, PRIORITIZING **UNREGULATED PRODUCTS**

ndia is recalibrating its agricultural export strategy, with a notable emphasis on Lunregulated products to enhance global trade presence. The government has pinpointed 20 farm items, including fruits, alcoholic beverages, meat, milk derivatives, and cereals, with a combined global import value exceeding \$405 billion. However, India's current share in the world exports of these products stands at a modest \$9.03 billion, merely 2.23%.

According to the Agriculture Processed Food Export Development Authority (APEDA), the unrealized export potential for these items amounts to a staggering \$56.7 billion. The government aims to devise a detailed action plan within the next three to four months to capture 10% of the global trade in these identified products over the next five years. This strategy entails close collaboration between APEDA, state governments, and the Ministry of Agriculture to pinpoint production clusters requiring focused attention.

Recognizing the challenges posed by frequent export restrictions on essential agricultural commodities, the government is shifting its focus to unregulated sectors. The objective is to promote sustained growth in agriculture exports while ensuring surplus commodities are seamlessly connected to global markets. Notably, exports of regulated commodities like wheat, rice, sugar, and onions will only occur if there is a surplus.

Despite recent declines in agriculture exports due to export bans and regulatory constraints, certain products such as fresh fruit, buffalo meat, processed vegetables, basmati rice, and bananas have shown positive growth. Basmati rice exports, for instance, surged by 22% to \$5.2 billion during the period under review.

While geopolitical tensions in the Middle East between Iran and Israel have raised concerns, there hasn't been a significant impact on agriculture exports thus far. However, authorities remain vigilant and are closely monitoring the situation for any potential disruptions in trade.

#### INDIAN GOVERNMENT ANTICIPATES FOOD PRICE RELIEF FOLLOWING ABOUE-NORMAL MONSOON PREDICTION



The Ministry of Finance highlights expectations for a reduction in food prices postmonsoon, backed by the India Meteorological Department's forecast of above-normal rainfall. Food inflation, driven by elevated vegetable and pulse prices, has prompted government interventions like stock limits and imports.

Negotiations with countries like Brazil and Argentina aim to secure long-term pulse imports. CRISIL's report echoes optimism for easing vegetable prices post-June, contingent upon favorable monsoon distribution. Despite March's vegetable inflation decline to 28.3%, volatility persisted throughout fiscal 2024. The Reserve Bank of India flags weather shocks and geopolitical tensions as risks to food prices, while expressing optimism for Kharif crop prospects. Globally, nations including Germany, Italy, and the UK also grapple with high food prices, necessitating concerted efforts to mitigate pressure.

### IRDAI'S LANDMARK MOVE: ELIMINATING AGE LIMITS FOR HEALTH INSURANCE **ACCESS IN INDIA**

n a momentous stride towards enhancing the accessibility and Linclusivity of healthcare coverage, the Insurance Regulatory and Development Authority of India (IRDAI) has scrapped the age cap of 65 years for individuals procuring health insurance policies. This pivotal departure from conventional norms marks a substantial shift towards ensuring comprehensive protection for individuals of all age brackets.

The elimination of the maximum age restriction for acquiring health insurance policies underscores IRDAI's dedication to fostering a healthcare ecosystem that is more accommodating and equitable. Previously, individuals faced limitations due to the age ceiling of 65 years when endeavoring to obtain new insurance policies. However, with the recent amendment, which took effect on April 1, individuals of any age are now eligible to initiate the purchase of new health insurance policies.

In a recent gazette notification, IRDAI stressed the importance for insurers to tailor health insurance products to suit diverse age demographics. Insurers are encouraged to develop products specifically catering to senior citizens, students, children, maternity, and other specified demographics. Moreover, insurers are mandated to extend health insurance coverage to individuals with preexisting medical conditions of any nature.

Of significant note, insurers are now barred from rejecting policy issuance to individuals grappling with severe medical conditions such as cancer, heart or renal failure, and AIDS. This directive underscores a commitment to ensuring that individuals facing formidable health challenges have access to indispensable insurance coverage. Additionally, insurers are empowered to offer premium payment options in installments, thus enhancing convenience for policyholders.

The notification also specifies that

travel policies can solely be provided by general and health insurers. Moreover, there is no limit on coverage for AYUSH treatments, encompassing holistic systems like Ayurveda, Yoga, Naturopathy, Unani, Siddha, and Homeopathy. These treatments will receive coverage up to the insured sum without any cap, thereby ensuring comprehensive healthcare coverage for policyholders.

Another notable provision outlined in the notification permits policyholders with benefit-based policies to lodge multiple claims with various insurers, thereby amplifying flexibility and choice. Furthermore, the proposed regulation aims to address the grievances and claims of senior citizens through a dedicated channel, ensuring a more personalized and responsive approach to their specific needs.

Overall, IRDAI's decision to abolish the age limit for purchasing health insurance policies signifies a significant stride towards democratizing access to healthcare coverage in India. By dismantling barriers based on age and medical history, this regulatory reform empowers individuals to secure crucial protection against unforeseen medical expenses, thereby fostering greater financial security and peace of mind across all segments of society.

The Indian economy demonstrated resilience by registering a growth rate of 8.4% in the October-December period, surpassing expectations and marking its quickest pace in eighteen months. This growth momentum reflects the effectiveness of policy measures and the inherent strength of the economy in navigating challenges.

Moreover, the RBI anticipates stability in India's foreign exchange market, underpinned by comfortable foreign exchange reserves and a resurgence in capital inflows. These factors contribute to reinforcing the country's external resilience amid uncertainties in the global economic landscape. As India endeavors to align inflation with its target of 4%, the RBI



stresses the significance of data-driven decision-making. Although retail inflation decreased to a five-month low of 4.85% in March, the central bank remains vigilant, aiming for a lasting and sustainable alignment with the inflation target. The RBI's projection of retail inflation averaging at 4.5% in 2024-25 underscores its dedication to maintaining price stability.

Looking forward, the RBI underscores the importance of closely monitoring incoming data to gain greater clarity and confidence in the disinflation path. As the Indian economy continues its growth trajectory, supported by prudent policies and favorable economic indicators, the central bank remains committed to steering the economy towards stable and sustainable growth while addressing emerging challenges posed by both domestic and global factors.

In summary, the RBI's bulletin highlights the multifaceted nature of the challenges facing India's economy, while also acknowledging the positive indicators that underpin its growth prospects. Through proactive measures and a focus on datadriven decision-making, the central bank aims to navigate these challenges and foster a conducive environment for sustainable economic development.

# NASA'S TIMED TO SUSTAIN AN ENCOUNTER WITH DEFUNCT COSMOS 2221, RAISING **CONCERN**

ussia's defunct spy satellite Cosmos 2221 and NASA's TIMED spacecraft have sustained a close encounter in orbit as reported by space.com. Initially it was determined that both the satellites passed under 65 feet of each other. However, further studies revealed that the original distance was much lesser than the earlier calculation. Pam Melroy, the deputy administration of NASA stated that the satellites traveled




within 33 feets of one another. Space debris has been a major concern for a long time. Yunhai 1-02, the Chinese military satellite, in August 2021, was stuck with the space junk particles most likely to be a fragment from the 1996 launched Russian Zenit-2 rocket. The collisions concerning TIMED are getting more frequent with the increase in congestion in the Earth's orbit. Recently, 11500 spacecrafts are orbiting the Earth, among them 9000 are operational, as per ESA (European Space Agency). Approximately, 36500 pieces of junk is estimated with an average of 4 inches. NASA is working on this issue to fix the space debris problem with the implementation of passivating satellites in the upper phase of orbit to lessen the explosive potentials. The agency further highlights the need for immediate action to deal with the issue by introducing 'space sustainability strategy'

# **EUEREST, MDH MASALA BAND: GOUERNMENT** TO CALL ON DETAILS FROM SINGAPORE AND HONG KONG

he commerce ministry officials have recently reported that the root cause of the spice ban row will be determined following the exporters concern. The Government of India has evidently called on the details from Singapore and Hong Kong food safety regulators after the ban of exports of certain spices by Indian spice brands like Everest and MDH. The Spices Board of India is apparently settling the grounds of the ban. Moreover, the central cause of the objection and necessary actions will be





implemented along with the exporters concerned, as stated by the commerce ministry. Everest and MDH are the two widely used brands in India that have been banned in Hong Kong and Singapore for allegedly inclusion of ethylene oxide and pesticide beyond the acceptable limits. During the 2022-23 fiscal year, the country exported spices worth ₹32,000 crore. Cumin, spice oil, chili and curry powder, turmeric, cardamom and oleoresins are mostly exported. According to the officials, the ministry called on the details from the Centre for Food Safety and Singapore Food Agency and the Environmental Hygiene Department, Hong Kong. The food safety regulator has strict instructions to the consumers not to purchase these goods both for consumption and trading purposes.

### NASA TO INTRODUCE MOONQUAKE DETECTOR WITH THE ARTEMIS 3 LANDING

ASA announced that the Goddard Space Flight Center is working on the moonquake detector for astronauts to install it on the Moon followed by the landing of the Artemis 3 mission. It is planned to function on the lunar surface from three months up to two years and might become the chief station in the upcoming lunar geophysical network. Initially, Moonquakes were



perceived by Apollo missions while placing the seismometers within 1969 to 1972. These are produced by the tug of gravity similar to that of the ocean tides. The Moon's surface quivers as soon as it contracts and expands due to temperature fluctuations. But Scientists are yet to discover the seismic data from the lunar south pole that will enable them to analyze the global and local lunar surface structure. The space agency chose the instrument, LEMS (the Lunar Environment Monitoring Station) as the potential payloads of Artemis 3. LEMS is a dense seismometer to support the monitoring of ground motion in moonquakes. Various other candidate detectors are the Lunar Dielectric Analyser instrument, which is led by scientists at JAXA (Japan Aerospace Exploration Agency) and the Tokyo University and the Lunar Effects on Agricultural Flora Instrument led by scientists at Space Lab Technologies.

### MASSIVE STORMS HITS CHINA, 11 MISSING



s per the reports stated in the state media, tens of the thousands population have been evacuated away with the severe storms in southern China. Xinhua, the state news agency, confirmed that the heavy rainfall hit most areas. 11 people are reportedly missing along with 53000 of the population have been relocated. Among them 45000 were evacuated from Qingyuan (northern Guangdong city). The meteorological agencies

claimed chances of heavy downpour till Monday. The other neighboring provinces including areas of Guangxi, Guizhou, Fujian will also be impacted for a short term. The population of Guangdong is approximately 127 million, one of the most densely populated areas. In other areas like the town of Jiangwan, few were trapped in landslides, six were injured. The state broadcaster CCTV reveals that the flood is 5.8 meter higher than the alarming limit. The people took refuge in the public sports club due to the waterfront houses which were shattered by the layer of brown mud. Current reports state that the extreme weather conditions with grinding, droughts, severe floods and record heat in China are causing it to be the world's greatest emitter of greenhouse gasses.









# D. GUKESH TO BREAK GRANDMASTER GARRY KASPAROU'S 40 YEARS RECORD IN THE CANDIDATES CHESS TOURNAMENT

Gukesh was acclaimed by Grandmaster Garry Kasparov for the magnificent victory in the Candidates Chess tournament, flattering the title of the youngest world contender. The 17 years old Gukesh will compete against Ding Liren from China in the world title contest in November. Prior to Gukesh, Kasparov held the triumph of the youngest winner of the Candidates Chess tournament in 20 years in 1983-84. Hikaru Nakamura finished with nine points out of 14 with Gukesh who



played out a draw in his 14th and final match of the competition. His closest competitors, Ian Nepomniachtchi, Fabiano Caruana and Nakamura, all ended in 0.5 points adrift. Russia's Kasparov commented on Gukesh's historic win and termed it an "Indian earthquake in Toronto", indicating a major shift in power dynamics in world chess tournaments. Chennai born Gukesh received €111,000 after winning the Candidates Chess tournament. He appropriately, obtained massive praise outside the platform on his triumph. Gukesh's mother stated that Anand's contesting Magnus Carlsen in the World Championship clash, in 2013, inspired Gukesh to take up Chess as his sport. Kasparov further expresses his gratitude towards Viswanathan Anand, the sole other Indian to hit the Candidates Chess tournament, for Gukesh's victory.

# JANNIK SINNER TO UNDERGO AN ONEROUS TASK WHILE COMPETING CARLOS ALCARAZ AND NOVAK DJOKOVIC

annik Sinner shrugged off the notion of being the finest player in the globe, considering that he should not be collated with his top three contenders, Carlos Alcaraz and Novak Djokovic. The Italian player ranking number two can touch the top ranker Djokovic in the game if he gains a triumph in Madrid and appears in the Spanish capital with confidence along with an overwhelming record of 25-2 win loss for the season. Djokovic is currently reigning the Australian Open champion and happens to be the first player in the open era



to grip three consecutive titles in 2024. He is ranked number one in the ATP's (Association of Tennis Professionals) fixture to Turin, and is 1,650 score in advance to Daniil Medvedev the second placed player. Sinner had never been able to cut it past round three in any of his previous appearances in the Caja Magica and would be looking forward to switching from the current play. With the absence of Djokovic, Sinner grips the tournament and turned out as the lead player in Madrid, as he faced Lorenzo Sonego or Richard Gasquet in round 2.

### NARSINGH PANCHAM YADAU GETS ELECTED AS THE CHAIRMAN OF WTI

arsingh Pancham Yadav the former gold medallist of the Commonwealth Games is elected as the chairman of the Wrestling Federation of Indian Athletes Commission. Eight candidates opted for the seven positions followed by polling on the ballot paper. Among the elected seven, Narsingh was shortlisted by the commission. Prior to the 2016 Olympics, Narsingh stole the headlines when Sushil Kumar the two times Olympic medallist sought for a trial session against him. Sushil was



unable to attend the qualification event because of his injury. Sushil then advanced towards the Delhi High Court and soon after his plea was not granted, it was determined that Narsingh would represent India at the Rio Olympics. Moreover, there is an unexpected turn of events with Narsingh failing the medical examination. He was proscribed by the Court for four years of Arbitration for Sport even though NADA (the National Anti-Doping Agency) had considered him clean on the petition that states his failure in the test as a result of obstruction. Among the elected members of the Athletes Commission there is Sweta Dubey from Bengal, Bharti Bhaghei from UP, Sahil from Delhi, Khushboo S Pawar from Gujarat, Nikki from Haryana, and Smitha AS from Kerala.

he twice won Asian Games gold medalist Saurav Ghosal announced his retirement from the professional circuit. After retiring from the professional front, Ghosal will still continue to play for India. He holds a significant record after winning the commonwealth games thrice, along with a gold in the World Doubles Championships 2022 in Glasgow. Further, he won medals at the Hangzhou and Incheon Asian Games and is the sole Indian squash player to reach the world's top 10. The



Kolkata born player made his PSA debut in 2003 and won 281 among 511 contests on the PSA Tour. He struck 10 PSA titles and qualified for 18 final matches. With this, he hits 13 Indian Nationals titles and the later of those coming in 2020. However, he is yet left with the game and aspires to represent the nation for some more times. It social exclusion, gossip, sabotage, and hindering professional growth. Workplace mobbing can be a challenging and distressing experience for those who face it. It often involves targeted psychological harassment from colleagues, superiors, or subordinates. Here is a breakdown of each type with examples and their impact:

1. Verbal Harassment: Verbal harassment is a form of abuse that uses language to hurt or intimidate another person. Examples include:

- Name-calling or insults: Using disrespectful language to demean the dangers of being someone who does not form relationships, as
- Threats: Verbally threatening harm or danger.

- Mockery or ridicule: Making fun of someone in a derogatory these involve:
- Attacks on personal traits: Criticizing someone's appearance, intelligence, or background.
- Demeaning language: Using words to undermine someone's confidence.

This subhashita highlights the importance of using words wisely and avoiding verbal harassment, as words have the power to either create bonds or cause harm and division in relationships.

- 2. Social Exclusion: Social exclusion involves isolating someone from social networks or groups, often intentionally. This can include:
- Being left out of activities: Not being invited to social events or meetings.
- Avoidance: Deliberately avoiding a person or refusing to acknowledge them.
- · Rumors and gossip: Spreading unkind talk that isolates the individual.
- Exclusion from decision-making: Ignoring someone's input or excluding them from discussions.

For example, a team member is regularly left out of work-record. related meetings, leaving them feeling disconnected from their spans organizations and education settings, peers and work environment. When important projects arise, causing significant distress through verbal abuse, professional jealousy can lead to the exclusion of intelligent employees from participating.

> Here is one Subhashita from the "Hitopadesha" that speaks about the importance of including others and treating everyone equally: "सर्वेषां साधुजातीनां स्नेहं कुर्वीत सञ्जनो। स्नेहहीनः निन्धः स्यात् सञ्जनानां महीयताम्॥" A virtuous person forms bonds of friendship with all noble individuals. A person without affection becomes despised among the virtuous and falls out of their favor." This Subhashita highlights the importance of fostering relationships those who seek to obstruct your progress. with good and noble people and being inclusive. It warns against

they may face disapproval and exclusion from virtuous company.

- Loud and aggressive speech: Raising your voice or speaking 3. Gossip and Slander: Gossip and slander can damage an individual's reputation and cause emotional distress. Here is what
  - Gossip: Sharing personal information, rumors, or secrets about someone without their knowledge.
  - Slander: Making false, harmful statements about someone that could damage their reputation.

For instance, colleagues might falsely accuse a team member For instance, a colleague publicly criticizes a coworker's of being old fashioned in dressing, outdated or aged, any other personal conduct, causing their credibility to be questioned.

> The following subhashita emphasizes the destructive nature of spreading rumors and false information: "अशक्ताश्चाप्यनिष्टाय किं कृतं दूषणेन वः। उभौ दोषौ स्मरत्येनं रहसि च सत्सु च॥" Even an unintelligent person can harm you with slander; people remember both the act of slander and the person behind it, in private and in public." This Subhashita warns against the spread of slander and false accusations, highlighting that even someone with limited understanding can cause damage through harmful speech.

- 4. Sabotage of Work: Sabotage involves actions meant to disrupt someone's work or professional success. Examples include:
- Task obstruction: Intentionally interfering with someone's tasks or assignments.
- Undermining authority: Questioning someone's abilities or decisions in front of others.
- Blocking opportunities: Preventing someone from accessing career advancement.
- Misuse or destruction of materials: Hiding or damaging someone's work resources.
- Spreading false information: Sharing lies about someone's work to create distrust.

For instance, someone deliberately misplaces a colleague's work materials or gives them incorrect information to hinder their progress. Another example the files submitted to documentation team is misplaced so that the excellence of work will not be in

The importance of good conduct and mutual support in achieving goals, is emplhasized in the following subhahsitha: "उद्यतेऽशस्त्रपाणीनां येषां दृष्टिर्महारथाः। तत्क्षणे एव तेषां कुर्वन्ति प्राणापायं मुहरमुहः॥" When a person of great valor sees their enemy raising weapons against them, they strike back swiftly to end the danger."

This subhashita uses the metaphor of a warrior defending themselves from an armed opponent to explain how one must be vigilant and proactive in protecting themselves from harm. In the context of workplace sabotage, it suggests the need for awareness and decisive action to prevent or mitigate the damage caused by



others, much like mentors who help others advance in their careers. On the other hand, wicked individuals focus on causing harm and disruption, such as undermining professional development. The saying emphasizes the value of altruism and the dangers of sabotage and interference in others' growth.

Experiencing workplace mobbing is damaging, but seeking support, documenting incidents, and setting boundaries can help. Report the behavior following organizational policies, prioritize self-care, and seek higherup advice if needed. Employers should uphold respect, fairness, and inclusivity, with clear policies against harassment and discrimination. Promoting open communication fosters a safe and respectful work environment for all.
