FROM ILLITERACY TO OPPORTUNITY: THE GLOBAL CALL ON LITERACY DAY


very year on 8th September, the world comes together to observe International Literacy Day. First proclaimed by UNESCO in 1966, the day serves as a reminder of the power of literacy in shaping individuals, communities, and entire nations. It is not just about the ability to read and write, but about gaining the skills necessary to participate fully in society, access opportunities, and live with dignity.

Literacy is often described as the foundation of education. Without it, the doors to higher learning, meaningful employment, and social empowerment remain closed. Yet, despite decades of progress, UNESCO reports that millions of adults and children across the globe are still deprived of basic literacy skills. In many developing regions, factors such as poverty, gender discrimination, conflict, and lack of infrastructure continue to keep education out of reach for large sections of the population.

In the Indian context, International Literacy Day has a special significance. While urban centres have largely bridged the gap, rural communities still struggle with limited schools, shortage of trained teachers, and socio-economic barriers that discourage children from completing education. Women and girls in particular face cultural restrictions, early marriage, or economic pressures that prevent them from continuing their studies.



Several initiatives have been launched to address these great equalizer. challenges. Government programs like Sarva Shiksha Abhiyan and Beti Bachao, Beti Padhao have focused on universal education and girl child empowerment. Nongovernmental organizations too have played an important role by setting up community libraries, adult education centres, and after-school support classes in underprivileged areas. The success stories of women who, after gaining literacy, were able to start small businesses, participate in local governance, or simply help their children with homework, show the transformative effect of this basic skill.

However, literacy is not just about statistics or government schemes. It is about the ability of individuals to find their voice, claim their rights, and improve their lives. A literate society is better equipped to fight inequality, resist exploitation, and build democratic values. In the 21st century, where access to information shapes power, literacy acts as the

RAJE UMAJI NAIK: THE FIRST REVOLUTIONARY OF SWARAJYA

In the rugged hills of Pune district, during the early 19th century, when India groaned under the oppressive rule of the British East India Company, there rose a fearless warrior whose courage and sacrifice would ignite the flames of resistance. His name was Raje Umaji Naik, also known as the "Gadkari of Swarajya", a freedom fighter who became a living symbol of defiance, dignity, and devotion to the motherland.

Early Life and Inspiration: Born in 1791 in the small village of Bharud near Pune, Umaji belonged to the Ramoshi community, traditionally known for guarding forts during the Maratha Empire. From a young age, he grew up hearing stories of Shivaji Maharaj's bravery and the dream of Swarajya (self-rule). These tales filled his heart with pride and a burning desire to fight for justice.

Umaji witnessed firsthand the exploitation of farmers, heavy taxation, and harsh punishments inflicted by the British on common villagers. The onceproud land of the Marathas was now shackled by oppression, and Umaji could not bear the suffering of his people. Inspired by the ideals of freedom and equality, he vowed to dedicate his life to restoring the dignity of Bharat.

Raising the Banner of Revolt: By the 1820s, Umaji had gathered a band of loyal Ramoshi warriors who shared his vision. Using his deep knowledge of the Sahyadri hills and guerrilla warfare tactics inspired by Chhatrapati Shivaji Maharaj, Umaji began launching attacks on British camps, government treasuries, and corrupt landlords who sided with the Company.

Unlike ordinary rebels, Umaji fought not for personal gain but for his people. The wealth captured from British outposts and collaborators was

distributed among poor farmers and struggling families. In villages across Pune, Satara, and Ahmednagar, Umaji became a hero, a leader who protected the weak and punished oppressors.

The British Declare Him an Outlaw: Umaji's growing influence deeply unsettled the British administration. His raids were swift, precise, and unstoppable. Knowing the terrain better than anyone, Umaji and his men would strike at night and vanish into the hills by dawn. In 1827, the British officially declared Umaji Naik an outlaw and announced heavy rewards for his capture.

But no villager dared betray him, for Umaji had earned their

love and respect. He was not just a warrior; he was a guardian of the people. However, the British, using deception and spies, finally managed to corner Umaji and his companions.

Arrest, Trial, and Martyrdom: In 1832, after a fierce struggle, Umaji Naik was captured. The British hoped his surrender would crush the spirit of rebellion, but even in chains, Umaji remained

about resistance it was about ethics, equality, and service to humanity. His philosophy can be understood through his guiding principles. Umaji believed that living in chains was worse than death. His entire life was dedicated to protecting the dignity of his land and people, proving that courage can defeat tyranny. Belonging to the Ramoshi community, Umaji fought against both foreign oppression and social discrimination. To him, caste and

class were meaningless in the fight for justice. Umaji used his resources and strength to uplift the poor, protect the helpless, and ensure that his actions benefited the greater good. Inspired by Shivaji Maharaj's ideals, Umaji kept alive the dream of self-rule even when hope seemed lost. His rebellion sowed the seeds of resistance that later fueled India's freedom struggle.

Legacy and Inspiration: Though the British tried to erase his name from history, Raje Umaji Naik remains immortal in Maharashtra's memory. His story continues to inspire generations, especially those who believe in justice and equality. Statues, memorials, and folk songs celebrate his bravery, reminding us that freedom is earned through sacrifice.

Today, Umaji Naik is remembered as the "First Revolutionary of India's Freedom Struggle", even predating the 1857 uprising. His life teaches us that revolutions are born not in palaces, but in the hearts of those who dare to dream of justice.

The story of Raje Umaji Naik is more than a chapter in history it is a timeless lesson in courage, morality, and sacrifice. From protecting farmers to challenging the British Empire, Umaji's life embodies the highest ideals of the Indian Knowledge System: dharma (righteousness), seva (service), and swarajya (self-rule).

Even today, when injustice and inequality persist, his spirit calls out to us:

"Rise when your people suffer. Speak when silence is demanded. Fight when freedom is threatened."

Umaji Naik's dream of a free, just, and equal Bharat continues to live on—not just in monuments and songs but in every heart that refuses to bow before oppression.

unbroken. At his trial, when questioned about his actions, he boldly declared:

"I fought not for myself but for my people. When my motherland suffers, my blood cannot stay silent."

His words left the courtroom stunned. Despite appeals from villagers and leaders, the British sentenced Umaji Naik to death. On 3 February 1832, at the gallows of Pune's Yerawada Jail, Raje Umaji Naik attained martyrdom at the young age of 41.

His final words were said to be: "Swarajya is our birthright. My life ends, but my dream shall live forever."

Philosophy of Raje Umaji Naik: Umaji's life was not just

opportunities, remarked Apte Kaka in an interview with HULAHUL Times. Mr. Shrikant M. Apte, commonly known as Apte Kaka is a retired banker, former legal practitioner, and the founder of V4Organs Foundation. He has been working passionately to convert every human death into "New Life" by Noble Organ donation. Apte Kaka shares that he grew up in a highly cultured environment whereby serving people and being empathetic was valued a lot. These values given by his family planted the seeds of philanthropy in his soul.

Despite his desire to work for the society and make a difference, Mr. Shrikant shares that during his professional years he could hardly get any time to wholeheartedly engage in social work making him restless and dissatisfied. Thus, after retiring from bank and working for some time in court he finally decided to bestow all his attention to the welfare work. "I thought God has given me enough and I'm financially sound so I should work for people's welfare", says Mr. Apte.

On being asked about his entry into organ donation program and the establishment of V4Organs Foundation, he recalled his professional days when once he wanted to get himself registered for organ donation but faced a lot of formal issues due to lack of information and guidance from anywhere and anyone. Moreover, during those years he also joined an NGO named Rajhans Pratishthan Trust whose annual report about Organ donation wing intrigued him. So, his active engagement in the NGO's organ donation wing and the free hand given by the founders to work for this cause along with the welcoming coordination of Zonal Organ Transplant Centre paved the way for his entry into this cause and the establishment of V4Organs Foundation.

Coming from a totally different professional background, he initially invested his time and energy in attending the seminars and meetings that discussed various aspects of organ donation to understand it better.

The mission of his organisation lies in creating absolute awareness about Body Organ

donation, letting no stones remain unturned. They aim to work with their utmost ability and capacity furthered by various training sessions and presentations taken in various areas including Mahila Mandal, Temples, Gurudwara, Church etc. In their presentations they try to explain various dimensions of Body Organ donation like, about eye donation, skin

when his online training program started whereby, they try to give holistic knowledge to the Students enrolled; through various online presentations and books and study material posted on their free telegram channel that divides the entire curriculum into 8 units imparting knowledge to the students from the very basic to advance level. Mr. Apte himself

limited reach is a challenge and aims to reach as many people as possible and create more awareness.

His training program functions exceptionally well with a well-developed mechanism for testing the Intelligence Quotient and learning capacity through a questionnaire developed by the founder himself. These questionnaires provide students with a ReSubmission option allowing them to take the test as many times as they want until they achieve 100% accuracy.

Mr. Shrikant M. Apte has been recognised by the Maharashtra government for the incredible work that he does and upon asking him about his idea of success and social impact, he shared a few stories that are most dear to him. He shared a story of a 4-class worker in a hospital who signed up to donate his wife's organs after her death to contribute in this noble cause. Apart from this he also recalled a story of a lady who called him to share a story of her father who was not afraid of dying naturally but was afraid of dying of COVID because he then, would not be able to donate his organs and contribute his share in the welfarism. Witnessing such stories on a daily basis makes Apte Kaka say, "I have seen God, in the form of donors". He also takes pride in the kind social impact they are able to create when very young students of even 8th standard talk about organ donation and spread awareness around it.

Lastly, on asking him about a message he would like to give to the young changemakers, he said "you can do it, if you work", primarily focusing on the need to indulge in hard and on ground work and not on just mere words. The saying "Be the change you want to see in the world" goes really well with the idea held by Apte Kaka who motivates people to first contribute in organ donation if they too demand organ supply for their family members. He says that not everyone has to be a doctor in order to be a saviour, any commoner can be the one and give a new meaning to somebody's life, the only need is to have a pure intent and the realisation of one's responsibility towards the society.



donation, hand donation etcetera. V4Organs Foundation and Mr. Apte has taken around 400+ presentations so far in various societies. He calls Organ donation as his 'Life Mission'.

He then also shed light on the day-to-day functioning of this foundation talking about the efficiency of their administration which is mostly paperless and functions through mobile phones. Apart from working on donation registration they also work towards training young generation through their online training programs. Kaka believes that young people have scientific wisdom and clear understanding and they can create much more awareness when trained properly. Their online training program started during the COVID 19 Lockdown when any sort of movement was restricted. So that's

teaches students trough various video lectures on different themes. Moreover, in order to ensure effectiveness of this training program they have tied up with the National Service Scheme (NSS) of various colleges and universities which gives certain credit to the students on completion of the training along with an e-certificate. Mr. Shrikant also shares that their organisation got sponsorship which he used as incentive scholarship of rupee 1000 for the students enrolled in the training programs. This scholarship gave them the honour when they received the certificate and the scholarship by the principal of their college.

So far V4Organs has been successful in training around 21,000 students but this for Apte Kaka is not enough. He still feels that

GST REFORMS MAKE FARMING AFFORDABLE AND RURAL ECONOMY STRONGER



he GST Council, chaired by Sitharaman in its 56th meeting, has announced a major overhaul of India's tax structure, easing rates across essentials, medicines, vehicles, and farm-related goods. The reforms aim to spur domestic consumption, reduce input costs, and support rural livelihoods.

For agriculture, the biggest boost comes through reduced GST on machinery and inputs. Tractors below 1800 cc, tyres, hydraulic pumps, threshers, sprinklers, and diesel engines up to 15 HP now fall under the 5% slab,

making mechanisation and maintenance more affordable. Fertilisers like ammonia, sulphuric acid, and nitric acid, along with bio-pesticides and micronutrients, also shifted to 5%, helping stabilise farm input costs and encouraging sustainable practices.

In the dairy sector, GST on butter, ghee, milk cans, and preserved fruits and vegetables has been cut from 12% to 5%, lowering food

Finance Minister Nirmala prices, supporting women-led enterprises, and boosting exports by reducing wastage. Fisheries and apiculture also benefit, with natural honey and processed fish now taxed at 5%, aiding tribal and rural communities.

> Logistics costs have been addressed too, with GST on trucks reduced to 18% and third-party insurance on goods carriers lowered to 5%. Effective from September 22, these reforms are set to modernise farming, cut costs, and strengthen India's agri-

PUNJAB, HARYANA, CHHATTISGARH MAY SEE LOWER RICE OUTPUT **DUE TO HEAUY RAINS**



he government has reported that rice procurement from both kharif and rabi seasons stood at 54.52 million tonnes(mt) during October 2024 to August 2025, against the full-year target of 58.48 mt. The purchase objective for the electrical current kharif season is 46.35 mt. Last year, about 47.4 mt was purchased from the kharif crop, though the target was 51.16 mt.

The Department of Public Distribution and Food has concluded its purchasing strategies for the 2025–26 kharif marketing season in an interview with Provincial Food Ministers and the Food Company of India (FCI) season, beginning October. Apart from rice, a target of 1.92 mt has been fixed for coarse grains and millets (Shree Anna). The government has urged states to focus more on millet procurement to promote crop diversification and improve nutrition.

However, the rice target may be revised later since heavy rains and floods have damaged crops in several states. Punjab, which contributed the highest 11.61 mt last year, may face a decline in output. The India Meteorological Department has also predicted above-normal rainfall in key ricegrowing states such as Punjab, Haryana, and Chhattisgarh during September, which could further impact procurement.

UGC URGES COLLEGES TO PRIORITIZE MENTAL-HEALTH SURVEYS UNDER SUPREME COURT-BACKED INITIATIVE

he University Grants Commission (UGC) has called on all higher education institutions to make responding to mental-health and wellbeing surveys a top priority. These surveys are part of a National Task Force launched following a Supreme Court directive aimed at addressing the rising number of student suicides.

The Task Force's portal, launched in August, provides structured questionnaires in both English and Hindi. It invites responses from students, parents, faculty, mental-health professionals, and the public. Separate institutional surveys are available for heads of colleges to share data on reported suicides, existing support systems, and mechanisms for grievance redressal.


Tasked with spotting the root causes behind student suicides, the panel chaired by former Supreme Court judge Justice S. Ravindra Bhat aims to review current regulations and recommend stronger preventive strategies.



In July, the Supreme Court further mandated that all institutions implement a mental-health policy. Institutes must now comply with this requirement and submit monitoring reports within 90 days. The Supreme Court scheduled the next review of progress for October 27.

By prioritizing these surveys, colleges can contribute to a better understanding of student needs, helping shape proactive support systems and safeguard student wellbeing across the



Despite being taught in classrooms for years, these languages have lacked structured grammar resources until now. The initiative aims to address this by carefully documenting linguistic elements such as parts of speech, tense and aspect, phrase and clause structures, tone, vocabulary, and even clarifying orthography.

Once crafted, the grammars will be woven into textbooks that blend grammar lessons with prose, poetry, and translation, under the guidance of SCERT (State Council of Educational Research and Training) and NBSE (Nagaland Board of School Education). To ensure good teaching practice, educator training workshops including refresher courses at the university will support teachers in delivering the new material.

The project is led by Dr. Mimi Kevichüsa Ezung, Associate Professor and Head of the Department of Tenyidie. Tenyidie is the standardised form of the Angami language, used by the Angami people and speakers of related Tenyimia tribes.

Prof. Jagadish K. Patnaik, Vice Chancellor of Nagaland University, described this as more than an academic task it is a cultural mission, meant to safeguard and uplift the rich linguistic heritage of Naga communities.

INDIA'S DIESEL EXPORTS TO EUROPE HIT RECORD HIGH AS 2026 BAN NEARS; RELIANCE ADAPTS STRATEGY

ndia's diesel exports to Europe surged to record levels in August as refiners and traders raced to secure supplies ahead of the Leuropean Union's (EU) planned 2026 embargo on fuels derived from Russian crude. The sharp rise highlights India's growing dominance in the global energy trade while posing potential challenges for Reliance Industries, the country's largest fuel exporter, as the deadline approaches.

A Surge Driven by Anticipation

According to energy analytics firm Kpler, India exported 242,000 barrels per day (bpd) of diesel to Europe in August a staggering 137% increase compared to last year and a 73% jump from July. A separate study by Vortexa placed the figure at 228,316 bpd, still reflecting a massive 166% annual rise.

The sudden spike comes as EU members prepare for a 2026 ban on fuels refined from Russian crude, even if processed outside Russia. Indian refiners led by Reliance Industries have been taking advantage of discounted Russian Urals crude, refining it into diesel, and re-exporting it to Europe. However, once the embargo kicks in, such supplies will no longer be permissible.

An energy analyst explained, "European buyers are stockpiling diesel now to secure inventories before sanctions restrict supply."

Reliance Industries at the Center

Reliance Industries, which operates the world's largest refining

complex at Jamnagar, contributes significantly to India's fuel exports, with one-fifth of its shipments currently heading to Europe. The upcoming EU restrictions could impact Reliance's export revenues, making diversification critical.


In anticipation, Reliance has begun purchasing premium Murban crude from Abu Dhabi, gradually reducing its dependence on Russian Urals and Middle Eastern grades. This strategic shift aims to shield its refining operations from potential disruptions once the EU ban takes effect.

Despite these challenges, financial experts remain optimistic. A Jefferies report notes that Russian crude accounts for just 2% of Reliance's overall EBITDA and predicts a 15% profit growth in its Oil-to-Chemicals division during the first half of 2026, supported by strong diesel margins and stable auto-fuel spreads in India.

Global Energy Dynamics in Transition

India's export spike underscores how geopolitics is reshaping global fuel markets. With Europe cutting ties to Russian-linked fuels, Gulf refiners, unaffected by the ban, are expected to capture a greater share of the European market post-2026.

In the short term, however, Europe's rush to secure supplies has strained logistics. Freight costs are rising, shipping routes are longer, and supply constraints could drive diesel prices higher for European consumers this winter.



The Road Ahead for Indian Refiners

While August's export boom highlights India's increasing clout, the 2026 embargo forces a strategic pivot. Reliance and other refiners will need to focus on diversifying export markets across Asia, Africa, and Latin America to offset potential European losses.

In the near term, Europe's stockpiling offers a profit windfall for Indian exporters. But over the long term, sustained success will depend on securing new crude sources, expanding trade partnerships, and leveraging India's refining edge to stay competitive in a rapidly evolving energy landscape.

GST 2.0: INDIA'S LANDMARK TAX REFORM TO BOOST GROWTH AND EASE BURDENS

n one of the most significant tax reforms since the launch of the Goods and Services Tax (GST) in 2017, India has unveiled a L sweeping overhaul of its indirect tax system. After a marathon GST Council meeting, Finance Minister Nirmala Sitharaman announced the "GST 2.0" framework, designed to simplify compliance, reduce household expenses, and accelerate economic growth. The reforms, taking effect on September 22, 2025, are strategically timed ahead of the festive season to stimulate consumer demand and strengthen the economy.

Key Features of GST 2.0

- 1. Simplified Tax Structure: The current four-tier GST regime has been streamlined into three slabs:
- 5% on essential goods and basic services.
- 18% on most products and services.
- 40% on luxury and harmful items such as premium cars, tobacco, alcohol, and gambling services.

The abolition of the 12% and 28% slabs aims to make the tax system more transparent and predictable for consumers and businesses.

- 2. Relief for Healthcare and Education: Life and health insurance premiums, critical medical treatments, and school supplies have been made fully GST-exempt. Analysts say this will reduce household spending and improve access to essential services.
- 3. Green Push for Renewable Energy: GST on solar panels, wind turbines, and commercial drones has been cut to 5%. The move is expected to accelerate renewable energy adoption and support India's

long-term climate goals.

4. Easier Compliance for Businesses

Key measures include:

- Pre-filled tax returns to cut manual errors
- Faster refund processing
- Simplified registration for e-commerce sellers

These reforms particularly benefit small and medium-sized enterprises by reducing compliance costs and boosting efficiency.

Industry and Market Reactions

The reforms have been widely welcomed across sectors:

- Retail & FMCG: Reliance Retail pledged to pass on tax savings directly to consumers, while ITC Chairman Sanjiv Puri called GST 2.0 a "consumption booster."
- Automobiles: Taxes on small cars and two-wheelers have been reduced from 28% to 18%, while farm equipment now attracts just 5%, giving a strong push to rural demand. Luxury cars, however, will face a steep 40% rate.
- Healthcare & Pharma: Exemptions on life-saving drugs and insurance are expected to make treatments for chronic illnesses more affordable.
- Renewable Energy: Industry players welcomed lower taxes on solar and wind technology, predicting faster adoption of clean solutions.

Economic Impact and Growth Outlook

Economists expect GST 2.0 to lift consumption and growth:

- Inflation Relief: Lower tax rates could reduce inflation by up to 90 basis points.
- Consumer Spending: The State Bank of India projects an additional ₹2 lakh crore in spending during FY2026.
- Revenue Impact: The government may face an annual shortfall of about ₹85,000 crore, though higher demand could offset losses.
- GDP Growth: Standard Chartered Bank estimates that the reform could add 0.35–0.45 percentage points to GDP growth by FY2027.

Former Finance Minister P. Chidambaram cautioned that tax reforms alone may not ensure sustained growth without parallel improvements in infrastructure, investment, and jobs.

The Road Ahead

GST 2.0 represents a balancing act between boosting consumption and managing fiscal stability. By creating a simpler, consumer-friendly, and business-oriented framework, the government hopes to energize households and industries while pushing India closer to its \$5 trillion economy goal.

With the festive season approaching, early signs point to rising consumer sentiment. The true test, however, will lie in sustaining demand and ensuring that revenue losses are offset by long-term growth. For now, GST 2.0 stands as a landmark reform that could reshape India's economic trajectory for years to come.



INDIA SIGNS APPREHENSION OVER MOBILITY AND NON-TARIFF BARRIERS IN EU



ndia has raised critical issues regarding hurdles faced by its exporters in the European Union (EU), Lespecially in Germany. GREEN CREDIT ONLY AFTER 40% CANOPY OVER 5 YEARS: ENUIRONMENT MINISTRY

he Union Environment Ministry has announced new guidelines for the Green Credit programme, linking it directly to the survival and growth of plantation efforts. According to the notification Green Credit will only be granted once a plantation achieves a canopy density of at least 40% after five years of restoration. This step has been introduced to ensure that the scheme does not become a mere plantation drive on paper but truly contributes to ecological balance. The ministry explained that the methodology for calculating Green Credit will focus on long-term growth, survival rate of trees, and the ability of the plantation to create real green cover. Officials highlighted that this decision will encourage accountability



among agencies and individuals taking part in the programme. Instead of counting saplings planted, the emphasis will now be on how many survive and grow to form a healthy canopy. As it is the larger climate strategy, India has launched the Green Credit initiative to double up the carbon sequestration and advance sustainable development according to experts, this practice will promote real ecological gains and prevent tokenistic plantation efforts. By setting up a five-year benchmark, the government hopes to build resilient green zones that can stand the test of time.



LEGIBLE MEDICAL PRESCRIPTION DECLARED A FUNDAMENTAL RIGHT BY PUNJAB AND HARYANA HAC

n a significant ruling, the Punjab and Haryana High Court has declared that every patient has the Indumental right to receive a legible Medical Prescription and diagnosis. The judgement was delivered on August 27, while hearing an anticipatory bail please in an alleged rape case reported in Haryana. During the proceedings, the court examined the medico-legal recovery of the accused and found that not even a word or letter was legible. Taking action on this, the bench ruled that illegible prescriptions compromise their safety on this and also deny patients their rights to proper treatment. The court emphasized that clear writing is necessary to enable accurate diagnosis, dispensing of medicines and avoiding medical errors, in addition, it found the availability of intelligible medical records to be directly linked the right to health and life under Article 21 of the Indian Constitution. As a reminder to the doctors and the hospitals, the



judgement serves that the patients rights cannot be overlooked in the name of medical practice. By holding legible prescriptions as a fundamental right, the court has set a strong reference point for accountability and transparency in healthcare.

KULASEKARAPATTINAM TO HOST ISRO'S SSLV LAUNCHPAD



n 27th August 2025, the Indian Space Research Organisation (ISRO) achieved another milestone in India's space journey by laying the foundation stone of the Small Satellite Launch Vehicle (SSLV) launched at Kulasekarapattinam, Tamil Nadu. enhancement will lower the burden on Sriharikota's existing launchpads, controlling risks and maximizing output. New setup in this will reduce the load of work on Sriharikota, making it smoother launches. countries must convince the BWF that they can handle sponsorship, audience demand, and the facilities needed to successfully host the championship. In the last 17 years, other nations such as China, Spain, Denmark, and Japan were more aggressive in bidding. The BWF Championship seems to be the right time to come back, as India is now both a top market in sports and has good infrastructure and facilities to sponsor it.



Paneer Lababdar Rich & Creamy Without Onion & Garlic
